Part I

General / Landing Fees

1. General

For aircraft landings and use of the facilities of the Hof / Plauen commercial airfield, the airline, the aircraft operator, or the natural or legal person who is using the aircraft must pay fees to the aerodrome operator in accordance with these Fee Regulations.

The fees set out in these Fee Regulations shall be payable upon landing. They must be paid in cash in euros or by EC/credit card, or by direct debit authorisation, subsequent to landing and before take-off. In special cases, another method of payment may be possible after prior agreement with the aerodrome operator. Upon request, an invoice shall be issued for more than €50. Amounts under €50 are to be paid in cash or by direct debit.

The fixed fees are fees within the meaning of § 10 (I) of the Value Added Tax Act (UStG) (Value-added Tax). The party liable for payment must therefore pay the value added tax valid at the time of invoicing separately, unless there is a value added tax exemption pursuant to the Value Added Tax Act.

Assessment bases

For aircraft, the landing fees and other fees are calculated on the basis of the maximum take-off weight entered in the aircraft's registration certificate and upon presentation of an official German noise certificate for the relevant aircraft.

Corresponding foreign noise certificates, corresponding manufacturer's data or comparable documents from an approval authority shall be deemed equivalent to the corresponding noise certificate.

The noise certificate shall be submitted to the aerodrome operator's fee calculation office for calculation of the fee at the latest before the take-off that will follow the landing.

The sale of aviation fuel is to be undertaken in the name and for the account of Flughafen Hof-Plauen GmbH & Co. KG. The prices set and stored in the accounting system (aerops AMS software) at the time of refuelling shall apply.

Landing fee remuneration

The following reductions are granted for directly consecutive VFR aerodrome traffic circuits:

- For 5 aerodrome traffic circuits, of which 1 landing is free
- For 10 aerodrome traffic circuits, of which 2 landings are free

This does not apply to IFR flights.

Landing fee for gliders – flat rate: €5.00

PPR launch fee for balloon launches on the aerodrome site: €6.00

The landing fee must be paid at the latest before the next take-off.

In special cases, it may be paid subsequently by prior agreement with the aerodrome operator.

For special events (e.g., airshows, fly-ins, aircraft exhibitions, etc.), special conditions and fees may be granted in deviation from Table 3.1 by prior agreement with the aerodrome operator.

2.2. Go-Around

A landing fee must also be paid when touching down with immediate subsequent take-off (go-around procedure).

2.3. Consecutive flights without touchdown

Two consecutive approaches (low approaches) without touchdown is considered to be one landing. Therefore will be one landing fee invoiced.

2.4. Flight movements of a helicopter within the aerodrome area

No landing fee shall be payable for a helicopter's movement within the aerodrome area, which is equivalent to an aircraft driving on its wheels.

Helicopter hover flights (training) without clear set-down procedures are charged at a flat rate of 1 landing per 15 minutes.

2.5. Fee for infrastructure usage of airport

A flat-rate infrastructure charge of €2.00 per ton of MTOW (plus VAT) will be levied for each flight movement to cover the repair and maintenance of the infrastructure.

Flights in accordance with sections 3.1 and 3.2 (training/instruction flights) are exempt from this charge.

3. Training and familiarisation flights

3.1. Training flights

Within the meaning of these Fee Regulations are flights which a student pilot performs as part of his or her training at an approved training organisation (aviation training school) and which are necessary for the acquisition of a pilot's licence or additional ratings within the meaning of the Ordinance on Aviation Personnel (LuftPersV). This also includes instructor flights to acquire further ratings as well as refresher training for licence renewal with an FI (A) or CRI (A).

3.2. Induction flights

For the purposes of the schedule of charges, induction flights are flights which serve to provide aeronautical and technical instruction to pilots. The pilots to be instructed must hold the pilot licence prescribed for the type of aircraft used. The instructor must be on board the aircraft being used.

3.3. Fees

Landing fees for training and induction flights are 50% of those given in the table of fees.

3.4. Discounts

For training flights within the meaning of Clause 4.1, the following reductions shall be granted <u>for directly consecutive</u> VFR aerodrome traffic circuits:

- For 5 aerodrome traffic circuits, of which 1 landing is free
- For 10 aerodrome traffic circuits, of which 2 landings are free

This <u>does not</u> apply to IFR flights. The airport operator also grants the above discounts for non-school flights (but not IFR) for training purposes, provided that the circuits are performed directly after one another.

4. Surcharge to the landing fee (PPR fees)

A surcharge to the landing fee is payable if a landing or take-off falls outside the published operating hours. The amount of the surcharge is set out in Part II of these Fee Regulations. The time must be agreed with air traffic control in good time beforehand.

There is no legal entitlement to a take-off or landing that falls outside the published operating hours.

The surcharge on the landing fee (PPR fee) does not include any additional personnel provided. This will be invoiced separately by the airport operator.

5. Fee for emergency landings

No landing fee shall be payable in the event of emergency landings due to technical malfunction of the aircraft and due to need for urgent medical service for crew or passengers.

- · Diverted landings are not considered emergency landings.
- · Precautionary landings are not considered emergency landings.

6. Service flights

No landing fee is payable for official flights of a civil aviation authority of the Federal Government or a state of the Federal Republic of Germany or for aircraft of the police and federal police.

7. Exemption from the landing fee

Flights where an actual landing attempt is unsuccessful after one or more unsuccessful approaches due to unforeseen circumstances (e.g., due to an event on board the aircraft, at the aerodrome, or because of weather or air traffic control instructions) are exempt from the fee.

Flights operated pursuant to Clauses 6 and 7 of these Fee Regulations are exempt from the approach fee

8. Fees in accordance with the Air Navigation Services Arrival and Departure Cost Ordinance (FSAAKV)

Pursuant to § 27d (1) (b) of the Air Traffic Act (LuftVG) in conjunction with § 1 (1) (a) FSAAKV, Flughafen Hof-Plauen GmbH & Co.KG must levy air traffic control or approach fees. The fees shall always be collected in the name and on behalf of the air navigation service provider currently working for Hof-Plauen Airport.

Calculation of air traffic control fees or approach fees shall be pursuant to the provisions of FSAAKV and with the associated statutory regulations in their current version.

The calculation shall be performed using the following formula and the current fee rate:

Fee = (MTO M in t / 50) ^ 0.7 (rounded to 2 digits) * current fee rate

The current fee rate shall be calculated pursuant to § 2 (2) FSAAKV

The calculation shall be performed <u>only once</u> per flight movement, even if aerodrome traffic circuits or multiple approaches are undertaken.

The counting unit is the landing only.

A calculation shall be performed even if there has only been one approach without landing (low approach).

Approach fees shall only be incurred if air navigation services are provided by an air navigation service provider within the scope of the obligation pursuant to § 27d (I) (b) LuftVG in conjunction with FSAAKV.

For aircraft under 2to. MTOW, the fees shall be waived in whole or in part on behalf of the air navigation service provider in accordance with § 9(7) of the Ordinance Regulating the Procedure for the Commissioning of Air Navigation Service Providers (FSBV).

Price protection clause

The following generally applies to hangar storage (also for existing hangar rental agreements) in order to safeguard the price development from January 1, 2025 with regard to the aforementioned fees:

The prices for the hangar storage fee, whether for one-off payments or for recurring payments, are subject to value protection in accordance with the "Harmonized Indices of Consumer Prices for the Federal Republic of Germany" (HICP) published by Eurostat at https://ec.europa.eu/eurostat/.

The change in the HICP is always expressed as a percentage and the change always relates to the value of the previous year. The price adjustment is based on the arithmetic mean of all resulting changes in the index value compared to the previous year. The aerodrome operator shall assert the value adjustment once a year by June 30 of each year at the latest in the form of a new schedule of charges. The basis for the next value adjustment shall be the currently valid fees of the last fee schedule as amended.

The monthly index values of the HICP between the months of January and December of each year are used as the basis for calculating the arithmetic mean of the HICP and a possible price change as a result. The price adjustment may result in an increase or reduction in the fees for hall rental. If this value adjustment component is omitted, it shall be replaced by the respective successor component or, in the absence of such a component, by another suitable value adjustment component that comes as close as possible to the omitted component in economic terms.

Calculation on the occasion of hangar appointments of maintenance terms:

Storage charges according to the above calculation basis shall be charged as soon as the hangar visit is completed and as long as the aircraft remains stored in the hangar <u>until collection</u>.

The same applies to periods before the start of the maintenance date set by the hangar. Customers will be advised of this by the Aeronautical Operations Department! Customers of the maintenance company based at the Hof Airport are <u>not</u> generally entitled to hangar space.

Hall rental agreements:

For permanent storage by means of a hall rental agreement, the conditions stipulated therein shall apply.

4. Surcharges to the landing fee

4.1. PPR-Fee (fight operations outside opening hours)

There is a surcharge if a landing or take-off takes place outside the published operating hours (PPR). This fee is also due if the take-off or landing did not take place, but the personnel was kept on stand-by.

Cancellation free of charge is possible with air traffic control during operating hours on the same day. Additional fees may apply for cancellation (fee for coordination costs in accordance with Section 5).

Aircraft stationed at the airfield with a hangar rental contract will not incur any costs in the 1st hour before/after the operating time after confirmed PPR clearance.

4.2. Snow removal and/or de-icing of the movement areas

4.2.1 Mechanical snow clearance for take-offs and/or landings outside operating hours including material consumption per hour or part thereof per clearing/sweeping device: €300.00

The aerodrome operator is responsible for the runway's safe operational condition.

In this context, the operator shall decide whether, in addition to mechanical clearance, the runway, and if necessary, taxiways must be de-iced in order to ensure operational safety.

The costs for an additional, necessary de-icing are therefore automatically added to the normal clearing.

4.1.2. De-icing of the runway with a sprayer vehicle and de-icing agent:

on request per Ltr / take-off and/or landing

All work (points 4.1.1 and 4.1.2) plus personnel costs per 14 hours or part thereof. see Clause 9

The cost of the services shall be paid even if the take-off or landing <u>does not</u> take place after clearance and/or de-icing for reasons beyond the control of the aerodrome operator, but the services have been provided by the aerodrome operator.

For stationed aircraft with a hangar rental agreement, a reduced flat rate applies in the amount of the personnel and clearing equipment deployment, **up to a maximum of €150.00.**

4.3. Surcharge for airfield lighting

Airfield lighting surcharge (if before sunrise/after sunset) – flat rate:

€12.00

4.4. Surcharge for Low Visibility Take-offs (LVTO)

For take-offs during LVTO operation, an emergency generator shall be used in accordance with regulations.

Operation of the emergency generator per ½ hours or part thereof:

€50.00

4.4 Other PPR surcharges

Costs and fees for additional permits and approvals (e.g., external take-off and landing permission) by the aviation authority (Northern Bavaria Aviation Authority) shall remain unaffected.

All of the above surcharges <u>do not</u> apply to "Flying without an Air Traffic Controller (FOF)" within the scope of the corresponding permit issued by the Northern Bavarian Aviation Authority.

In the FOF operating mode, a flat-rate service fee of €7.50 per aircraft is charged for the upstream provision of fire protection equipment on the FOF vehicle and the subsequent recording and invoicing of these aircraft movements only for aircraft stationed at the airfield, irrespective of the aircraft movements performed.

The respective user has to provide an appropriate towing vehicle for the trailer him/herself if the FOF-Car ist not available!

6. Aircraft cleaning (self-cleaning incl. disposal)

If the cleaning of aircraft is carried out in third-party laundry (by third-party companies), a lump sum of EUR 100.00 will be charged for this.

7. Passenger Handling

For open-ticket-sale flights with passengers, in particular flights subject to Regulation (EC) No. 1254/09 (alternative security measures for flights with passengers on open tickets), the airport operator shall provide a waiting room and facilities for passenger handling. The airport operator's staff shall also carry out the handling, unless otherwise agreed with the respective flight operator. The airport operator shall charge a fee of €12.50 plus VAT per passenger for this service. If separate agreements have been made between the flight operator and the airport operator, these shall apply.

8. Luggage service

11. Airport fire brigade

Use the airfield fire-fighting vehicle (FLF) or other fire-fighting equipment as well as the deployment of personnel for purposes other than the intended fire protection for flight operations, is subject to a fee.

11.2. Settlement of recourse claims

The aerodrome operator reserves the right, in the case of use/operations in accordance with Clause 10.1.1, which result in a downgrading of the fire protection at the aerodrome and thus in a restriction of flight operations or their complete cessation, to additionally charge, in whole or in part, for any recourse claims arising from aerodrome users.

12. Sale of aviation fuels (AVGAS 100LL un d JET Al)

For the sale and billing of aviation fuels, only the prices set by the aerodrome operator and stored in the billing system (airport software) <u>at the time of refuelling shall apply</u>.

Prices quoted in notices and on the website are subject to change. All taxes and duties are included in the sale price. Fuel is sold on behalf of and for the account of Flughafen Hof-Plauen GmbH & Co.KG. Our supplier the WAHR ENERGIE GmbH is a certified fuel supplier for JET-A1 and AVGAS100LL. Subject to change without notice.

These aerodrome Fee Regulations shall enter into force on 1 October 2025 and shall replace the Fee Regulations dated 01/02/2024.
